

The Screening Committee met on **3rd March, 2014 at 10.30 A.M** in the Conference Hall of the Commission to consider the proposals of Seminars/Workshops, Legal Awareness Programme (LAP), Public Hearing/Awareness Programmes, Parivarik Mahila Lok Adalat (PMLA) and Research Studies, as per the agenda.

The approved agenda was placed before the Screening Committee.

AGENDA 1. LEGAL AWARENESS PROGRAMMES, PARIVARIK MAHILA LOK ADALAT, SEMINARS/WORKSHOP AND STUDIES RECEIVED IN R&S CELL.

The Committee was presented with 96 proposals of LAP (Non-NER), 2 proposals of PMLA, 156 proposals of Seminars/Workshops, Public Hearings and 22 proposals of Studies received in the R&S Cell and entered in the software. 7 proposals for Seminars/Workshops approved as ex-post-facto was also placed before the Committee. The Committee deliberated on the agenda presented before them alongwith the proposals.




Decision of the Committee:

- i) The Committee approved 38 camps @ Rs.50,000/- per camp for 19 NGOs/organizations (Non-NER). The financial implication of approval for LAP is **Rs. 19,00,000/-**.
- ii) The Committee approved 15 PMLA @ Rs.30,000/- per PMLA for 2 NGOs/Organizations for (Non-NER). The financial implication of approval for PMLA is **Rs. 4,50,000/-**.
- iii) (a) The Committee approved 5 National Seminars @ Rs.3.00 lakh per Seminar for 5 NGOs/Universities/organizations (Non-NER). The financial implication of approval for National Seminars is **Rs. 15,00,000/-**.

(b) The Committee approved 4 Regional Seminars @ Rs.2.00 lakh per Seminar for 4 NGOs/Universities/organizations (Non-NER). The financial implication of approval for Regional Seminars is **Rs. 8,00,000/-**.

(c) The Committee approved 16 State level Seminars @ Rs.1.00 lakh per Seminar for 16 NGOs/Universities/organizations (Non-NER). **The Committee, however, also considered proposals for 2 State level Seminars from Institute of Engineering for Women, Tamil Nadu as per their proposed amount of Rs.43,500/- and Rs.42,500/- respectively.** The total financial implication of approval for State level Seminars is **Rs. 16,86,000/-**.

(d) The Committee also approved 2 Chalo Gaon Ki Ore @ Rs.1.00 lakh each to one NGO with financial implication of **Rs.2.00 lakh**.

(e) Further, the Committee also approved 12 Public Hearings @ Rs.20,000/- per public hearing to 4 NGOs. The financial implication for approval of Public Hearing is **Rs. 2,40,000/-**.

iv) The committee approved **6** proposals for **Studies** on the basis of documents, relevance of the topic to the mandate of the Commission, quality of the proposals etc. The approval to Studies is subject to receipt of required documents, and review on file. The tenure and the budget would also be examined on file. The tentative financial implication of studies (in case Rs.3,00,000/- is maximum budget approved per study) would be **(6 X Rs.3,00,000 = Rs.18,00,000/-)**.

v) The Committee further recommended ratification of **7** proposals of seminars/workshops approved on ex-post-facto basis, by CP.

AGENDA 2. LEGAL AWARENESS PROGRAMMES, PARIVARIK MAHILA LOK ADALAT RECEIVED IN LEGAL CELL.

The Committee was presented with 20 proposals of LAP (Non-NER) and 6 proposals of PMLA as received in Legal Cell. 8 proposals for LAP approved as ex-post-facto was also placed before the Committee. The Committee deliberated on the agenda presented before them.

Decision of the Committee:

- i) The Committee approved 14 camps @ Rs.50,000/- per camp for 7 NGOs/organizations (Non-NER). The financial implication for approval of LAP is **Rs. 7,00,000/-**.
- ii) The Committee approved 40 PMLA @ Rs.30,000/- per PMLA for 6 NGOs/Organizations for (Non-NER). The financial implication for approval of PMLA is **Rs. 12,00,000/-**.

The Committee was presented with 20 proposals of LAP (NER), 5 proposals of Seminars/Workshops and 2 proposals of Studies received in North East Cell.

Decision of the Committee:

- i) The Committee approved 14 camps @ Rs.60,000/- per camp for 5 NGOs/organizations (NER). The financial implication for approval of LAP is **Rs. 8,40,000/-**.
- ii) The Committee approved 2 State level Seminar @ Rs.1.20 lakh per Seminar for 2 NGOs/organizations (NER). The financial implication for approval of State level Seminar is **Rs. 2,40,000/-**.
- iii) The Committee further approved 1 Study in the North East with tentative financial implication of study (in case Rs.3,00,000/- is maximum budget approved per study) would be **Rs.3.00 lakh**.


