The Screening Committee met on 9<sup>th</sup> July, 2014 at 11.00 A.M in the Conference Hall of the Commission to consider the proposals of Seminars/Workshops, Research & Studies, Legal Awareness Programme (LAP), Public Hearing/Awareness Programmes, Parivarik Mahila Lok Adalat (PMLA) as per the agenda proposed by Legal Cell, North East Cell and Research & Studies Cell respectively.

- 2. The agenda for Research & Studies and Seminars was prepared as per the categorization given below:-
- **List 1 contains** details of proposals which were as per topics/issues identified by the Commission for the year 2014-15 and all required documents as per the guidelines have been received.
- **List 2 contains** details of proposals which were as per topics/issues identified by the Commission for the year 2014-15 but all required documents as per the guidelines were not received.
- List 3 contains details of proposals which were not as per topics/issues identified by the Commission for the year 2014-15, mandatory documents were

missing/previous grant was not utilized/proposals not submitted according to the guidelines of the Commission.

- List 4 contains details of proposals which were approved on ex-postfacto basis under the directions of Chairperson.
- **List 5 contains** details of proposals which were recommended by Chairperson/Members/VIPs/SCWs etc.
- 3. The agenda for LAP/PMLA from Legal Cell and Seminars/Workshop, Research & Studies, LAP and PMLA from North East Cell was also prepared and placed before the Screening Committee as per the categorization above.
- 4. The committee deliberated upon the agenda as per **lists 1 & 2** and also considered a few proposals from **lists 3 & 5** on the direction of the chair of the Committee on the basis of robust rationale for considering such proposals.

# AGENDA 1. LEGAL AWARENESS PROGRAMMES, PARIVARIK MAHILA LOK ADALAT RECEIVED IN LEGAL CELL.

The Committee was presented with 566 proposals of LAP (Non-NER), 14 proposals of PMLA as received in the Legal Cell and entered in the system. As per categorization mentioned at para 2 above, 28 proposals of LAP were placed before the Committee as per list 1; 79 proposals under list 2; 459 proposals under list 3; 6 proposals for approved as ex-post-facto under list 4; and 5 proposals under list 5 was placed before the Committee.

The Committee deliberated on the agenda as per lists 1 & 2 presented before them. Proposals from list 5 was also considered on the direction of the chair subject to rationale advanced for consideration of such proposals.

### Decision of the Committee:

i) The Committee approved **52** camps @ Rs.50,000/- per camp for 23 NGOs/organizations (Non-NER as per **list 1**). The financial implication of approval for LAP is **Rs. 26,00,000/-.** 

- ii) The Committee approved **121** camps @ Rs.50,000/- per camp for 47 NGOs/organizations (Non-NER as per list 2 subject receipt of required documents). The financial implication of approval for LAP is **Rs. 60,50,000/-.**
- iii) The Committee approved **26** camps @ Rs.50,000/- per camp for 5 NGOs/organizations (Non-NER as per **list 5** subject receipt of required documents). The financial implication of approval for LAP is **Rs. 13,00,000/-.**
- iv) The Committee approved **10** PMLA @ Rs.30,000/- per PMLA for 2 NGOs/Organizations for (Non-NER as per **list 1 of PMLA**). The financial implication of approval for PMLA is **Rs. 3.00,000**/-.
- v) The committee further recommended for ratification of **28** LAPs for 6 NGO/organizations approved on ex-post-facto basis.

# AGENDA 2. LEGAL AWARENESS PROGRAMMES, PARIVARIK MAHILA LOK ADALAT, SEMINARS/WORKSHOPS AND STUDIES RECEIVED IN RESEARCH & STUDIES CELL.

The Committee with 396 was presented proposals Seminars/Workshops (Non-NER) and 47 proposals of Research & Studies as received in Research & Studies Cell and entered in the software. Further the R&S Cell had also prepared agenda for 267 proposals of LAP and 8 proposals 31st received upto January, 2014. Seminars/Workshops approved on ex-post-facto basis was also placed before The Committee deliberated on the Committee. agenda for Seminars/Workshops, Research & Studies, LAP and PMLA as per lists 1 & 2 presented before them. The Committee further considered proposals in lists 3 & 5 subject to receipt of required documents on the direction of the chair and on the basis of rationale advanced in favour of such acceptance.

### Decision of the Committee:

# a) Seminars/Workshops

- The Committee approved 2 State level Seminars @ Rs.1.00 lakh per Seminar for two NGOs/Universities/organizations (Non-NER) from list 1 as per the categorization mentioned in para 2 above. The financial implication of approval for Seminars is Rs. 2,00,000/-.
- ii) The Committee approved 13 State level Seminars @ Rs.1.00 lakh per Seminar for 13 NGOs/Universities/organizations (Non-NER); 1 Regional level Seminar @ Rs.2.00 lakh per seminar for 1 NGO/organization and 2 National Seminars @ Rs.3.00 lakh per National Seminar for 2 NGOs/organization from list 2 mentioned at para 2 above. The financial implication of approval for Seminars is Rs. 21,00,000/-.
- The Committee approved 2 State level Seminars @ Rs. 1.00 lakh per Seminar for two NGOs/Universities/organizations (Non-NER) from the **list 3** on the direction of the chair, subject to required receipt of documents and compelling reasons advanced in favour of such proposals. The financial implication of approval for Seminars is **Rs. 2,00,000/-**.
- iv) The Committee also approved six proposals of State level Seminars and one Regional Seminar from **list 5** @ Rs.1.00 lakh and Rs.2.00 lakh respectively, subject to receipt of required documents and robust rationale in favour of the same. The financial implication of approval for Seminars is **Rs. 8,00,000/-.**
- v) The committee further recommended for ratification of two Seminars/Workshop for two NGOs/organizations approved on expost-facto basis.

# b) Legal Awareness programme (LAP) and PMLA

- i) The Committee approved four LAPs @ Rs:50,000/- per camp for two NGOs/organizations from list 1, as per categorization mentioned at para 2 above. The financial implication of approval for LAP is Rs. 2,00,000/-.
- ii) The Committee approved 10 LAPs @ Rs.50,000/- per camp for four NGOs/organizations from list 2, subject to receipt of required documents. The financial implication of approval for LAP is Rs. 5,00,000/-.
- iii) The Committee also approved two LAPs @ Rs.50,000/- per camp for one NGC/organization from **list 5**, as per the direction of the chair subject to receipt of required documents and with compelling reasons for section of the same. The financial implication of approval for LAP is **Rs. 1,00,000/-**.

# c) Research & Studies

- the basis of documents, relevance of the topic to the mandate of the Commission, quality of the proposals etc. from list 2 proposed before the committee. The approval to Studies is subject to receipt of required documents, and review in file. The tenure and the budget would also be examined in file. If tentative financial implication of one study is taken as Rs.3,00,000/- then maximum budget approved for study would be Rs.15.00 lakh.
- d) Additional Agenda: Three proposals of Research and Studies approved in the Screening Committee meeting held on 28.1.2014.

### Decision of the Committee:

The committee decided that the organizations Tri Sansthan, Rajasthan, and Ranthambor Sewa Sansthan, Jaipur, Rajasthan may each submit a revised, redrafted, independent proposal for conducting the studies on the

topics/issues approved in the Screening Committee for financial approval of the proposal.

The Committee further decided that the organization Shardamba Multipurpose Mahila Organization, Karnataka may be asked to submit a translated copy of their MOA in Hindi or English for further review.

# AGENDA 3. SEMINARS/WORKSHOPS, LEGAL AWARENESS PROGRAMMES AND RESEARCH & STUDIES RECEIVED IN NORTH EAST CELL.

The Committee was presented with 22 proposals of Seminars/Workshops (NER), 27 proposals of LAP and two Research & Studies as received in **North East Cell**.

### Decision of the Committee:

# a) Seminars/Workshops (NER)

- i) The Committee approved one Regional level Seminar @ Rs.2.00 lakh per Seminar for one NGOs/organizations (NER list -1). The financial implication for approval of Seminar is Rs. 2,00,000/-.
- ii) The Committee approved two State level Seminar @ Rs.1.00 lakh per Seminar for two NGOs/organizations (NER List -2). The financial implication for approval of State level Seminar is Rs. 2,00,000/-.

# b) Legal Awareness Programme (NER)

- i) The Committee approved five camps @ Rs.60,000/- per camp for one NGO/organization (NER list -1). The financial implication for approval of LAP is Rs. 3,00,000/-.
- ii) The Committee approved 20 camps @ Rs.60,000/- per camp for five NGOs/organizations (NER list -2), subject to receipt of required documents. The financial implication for approval of LAPs is Rs. 12,00,000/-.

# c) Research & Studies (NER)

The Committee further approved one Study in the North East with tentative financial implication of study of Rs.3,00,000/-.

Therefore, the committee recommended that the organizations may be directed to invite the Chairperson and Members of the Commission for attending their programmes by sending invitation letters with date and address of the programmes sponsored by the Commission.
