

Minutes of the Screening Committee Meeting held on 25th October, 2013 at 10.00 A.M. in the Conference Hall of National Commission for Women, New Delhi.

At the outset, Joint Secretary welcomed, Hon'ble Chairperson, Members of the Commission. Thereafter, Joint Secretary briefed the Commission that the presence of Member Secretary was required for approval of expenditure as never before Screening Committee meeting has been held without Member Secretary. However, the Commission decided to conduct the Screening Committee in absence of Member Secretary.

i) Joint Secretary briefed the Commission regarding complaints received through Prime Minister Office alleging lack of transparency in approving proposals for financial assistance by the Commission. She proposed that the funds for conducting programmes may be evenly distributed all over the country with due diligence of the organizations receiving funds. She further presented that states like Uttar Pradesh, Rajasthan, Delhi had already received substantial percentage of funds therefore **she recommended that the proposals of States**

with negligible funds may be considered by the present Screening Committee. The Commission approved the same.

(Action: R&S Cell)

ii) New Member (North East) Ms. Laldingliani Sailo desired that the order on constitution North East Cell may be revised. She proposed that the North East Cell may utilize all the funds related to North East including funds related to publicity and awareness. It was decided that the Administration may issue a corrigendum in this regard. The Chairperson also directed that all the funds related to North East may be released through Ms. Laldingliani Sailo.

(Action: Administration Section)

Member, Ms. Nirmala Samant Prabhavalkar submitted a reply to a circular issued by Member Secretary regarding Members sending correspondence to Ministries, State Commissions, Rajya Sabha Secretariat etc. directly without the approval of Chairperson. In this regard, Member expressed her displeasure and further stated that she had never done the same. Other Members present i.e. Ms. Hemlata Kheria and Laldingliani Sailo shared the view. Member (NSP) requested the Administration to not issue general circulars in future. However, Joint Secretary clarified that public servants are trained to issue general and not individual targetted specific circulars to maintain cordial harmonious working condition and relationships, unless it becomes absolutely necessary.

The Commission deliberated on whether to point out the name of Member for deviation for directly sending correspondence to Rajya Sabha, PMO etc. In this regard, Chairperson clarified that the reference was drawn from several correspondence sent by M(CWK) with regard to Bill of Rights, wherein Member had issued letters to PMO, Ministry of Home Affairs etc.

iii) Commission decided that **in future such correspondence should be addressed to individual Members by name.** Chairperson further directed the Administration to take necessary action in this regard.

(Action: Administration Section)

iv) In continuation to the same, the issue of Press Release in Times of India dated 23.10.2013 regarding the News on Bill of Rights was also discussed. **It was decided that the Media report viz a viz decision in the Commission meeting held on 14.9.2013 may be processed on file.**

(Action: PR Cell)

v) It was further decided to discuss Bill of Rights in the month of December, 2013 to consolidate the views of the Commission whether to take the matter forward. However, Chairperson clarified that **as of now, the proposal of Bill of Rights is not approved by the Commission.**

(Action: Legal Cell)

vi) It was also decided in the meeting that **for any programme to be conducted by the Commission, the Administration may be given atleast two weeks time to examine the proposal for release of funds.** In the proposals details like purpose of the consultation, tentative invitees, resource persons, synopsis and expected outcome may be provided.

(Action: All Members/Legal Cell/R&S Cell)

Member (CWK) drew the attention on approval of a proposal of Seminar to be conducted in Jammu & Kashmir in the Commission meeting held on 14.9.2013. Member expressed that as per NCW Act, the Commission has no role in J&K. Therefore, the Commission may not undertake any activity in J&K. Another view was that the Commission may release funds for welfare activities in the State.

vii) On this issue, Commission decided **to refer the matter to Ministry of Law for seeking views on whether the Commission can release funds for welfare and awareness activities in the State of Jammu & Kashmir.**

(Action: Legal Cell/R&S Cell)

viii) The Screening Committee further approved that **the proposals for conducting Seminars, Workshops, Research Studies, LAP/Awareness Programmes and PMLA, received from Govt./Govt. accredited Colleges or Universities/Institutes may be approved on ex-post-facto basis,** as and when the proposals are received (after due examination).

(Action: R&S Cell)

ix) The Chairperson, NCW desired that the financial documents required after the programme has been conducted should be intimated to the NGOs in advance. The Chairperson was apprized that the sanction order issued to the NGO for release of 1st installment already contains the list of such documents. However, it was further informed that the same will be highlighted and reflected in bold in every sanction order issued in future.

(Action: R&S Cell)

x) The Joint Secretary further briefed the committee that in future the Agenda for the Screening Committee will be prepared State wise for Seminars, Conferences and LAPs and issue/topic wise for Research Studies. After deliberations, the **Screening Committee approved following proposals from the Agenda item placed before them:-**


