**Agenda Item No. 212//5:**

**Research Studies proposals recommended by Expert Committee for Financial Year 2020-21.**

The Commission accorded approval for the following as per details given in agenda item:

1. Administrative approval for selection of 11 (eleven) proposals, 6 Non- North East and 5 North East, subject to availability of funds.
2. Financial approval for 11 proposals for F.Y. 2020-21:
  - i. 6 proposals (Non-North East), would entail expenditure of Rs.97,22,492/- (Rupees ninety seven lakhs twenty two thousand four hundred and ninety two only). Out of this, 50% i.e., Rs.48,61,246/- (Rupees forty eight lakhs sixty one thousand two hundred and forty six only) may be released as first installment on receipt of requisite documents.
  - ii. 5 proposals (North East), would entail expenditure of Rs.63,19,496/- (Rupees sixty three lakhs nineteen thousand four hundred and ninety six only). Out of this, 50% i.e., Rs.31,59,748/- (Rupees thirty one lakhs fifty nine thousand seven hundred and forty eight only) may be released as first installment on receipt of requisite documents.


**Budget Allocation for the year 2020-21 and Expenditure incurred upto 31.12.2020**
